Retirement Fund Update

We are happy to inform you that the Retirement Fund is doing very well! Depending on the accounting standard used to determine the unfunded liability, your fund is between 107% -117% funded.

That puts your trust fund in the **top percentile of all public funds** in the country.

With the retirement of Mr. **Danny Zito**, the Retirement Board has hired Ms. **Susie Ardeshir**, as Executive Director/Chief Investment Officer. Ms. Ardeshir has extensive public fund and investment strategy experience and she has hit the ground running. The Retirement Board wishes Danny much happiness in the next chapter of his life.

While the Fund is very healthy financially, as Trustees, we are -- as a group -- embarking on a review of the Fund's governance. This is common practice when a new administrator is hired. We'll be reviewing best practices within the public fund universe, including a review of cyber security protocols with our custodial bank.

Big Changes to Retiree Health Care and Prescription Coverage

The County recently completed its procurement process for medical and prescription drug coverage for Medicare-enrolled retirees and their Medicare-enrolled dependents. A new, custom UnitedHealthcare Group Medicare Advantage plan for coverage was selected to replace AmWINS and **coverage will begin January 1, 2022**.

Retirees have received detailed information about the plan, as well as forms for those who wish to opt-out. All current AmWINS members will be automatically enrolled in the new plan and ID cards will arrive in early December.

Arlington County Board Chooses a New Logo

The County Board voted on the new logo Saturday, Sept. 18, 2021 — after more than 400 design submissions & 29,000 votes in two rounds of community feedback.

The chosen design represents Arlington's close relationship with DC and Alexandria and echoes how the County was formed, as well as its Potomac River border on the east.

The new logo will replace the previous logo and the County seal.

Arlington ECC Leads Nation in Remote Work

Arlington County Emergency Communications Center (ECC) is one of the first centers in the nation to implement capabilities that allow fire and emergency medical services (EMS) dispatchers and supervisors to deliver critical emergency communications services no matter where they are.

Arlington Fire-EMS dispatchers and supervisors are able work from a remote location, including from home. New capabilities in the 9-1-1 system allow for remote call-taking, dispatch, and supervision — breaking new ground in decentralizing and distributing public safety emergency communications.

American Rescue Plan Act (ARPA) Benefits Arlington

In March 2021, President Biden signed ARPA legislation, which provides states and localities with funds to support the ongoing public health response and help communities recover. Arlington is receiving \$46 million in two equal

allotments. The first allotment was received in May 2021 and the second one will come in May 2022. Arlington's allocation will focus on recovery and equity, including small business grants, housing assistance, workforce development, crisis intervention services, and transit services.

Tour of High View Park

ACREA members have found COVID-safe activities to enjoy this Fall. Several members

including Marcia Smith, Dottie Dake, and Melodee Melin, participated in the History Walking Tour of the Halls Hill-High View Park neighborhood. which was sponsored by the Langston Boulevard Alliance and the John M. Langston Citizens Association.

The Halls Hill community, which began in 1866, was settled by freed slaves and other free black people, and is located on Langston Blvd. (formerly Lee Highway), Culpeper and 17th Streets, and

George Mason Drive. Six important sites were highlighted in the tour and presentations: the Welcoming Area at North Cameron Street; Fire Station Number 8; Langston Elementary (which now houses the Langston-Brown Community Center); the Calloway Methodist Church and Mount Salvation Baptist, and the Segregation Wall.

The event is one of a number commemorating the Lee Highway name change and promoting understanding of the past and future of this

important County corridor. A major planning process is underway for the entire length of the boulevard. *
